October Forum

On October 2 at 10 am. Ms Pia Kinney joined us on Zoom to discuss her chapter in the *Nine African American Families*. This book grew out of a writing group of 9 to 12 women who wanted to hand down family stories, which led them to genealogy as part of their efforts to share. They chose stories, put the book together for loved ones, self-financed, got a grant through Dane County, and got enough copies for family members and Madison's libraries.

Pia Kinney James was born and raised in Madison. Her family has been here since the early 1900's. Her interest in genealogy grew from her mother's desire to find her family, both siblings and aunts and uncles. A searing look at what Black families encountered right here in Madison, in Wisconsin. Children taken from parents, split up, banished.

Pia discovered racism in her teens. She was the first African American female police officer in Madison, and spent 29 years as a community-oriented officer who put herself in others' shoes. Neighborhoods, schools were her focus. She has seen changes in both directions in the police department and is a proponent of Peace and Justice for all. The wealth of stories invited others to share their experiences. This was a very rich and satisfying time of discussion.

From Gloria Carter CWU in Wisconsin - Social Justice Statements

The following statement was proposed by Lynn McDonald at the annual meeting at Holy Wisdom Monastery on September 7, 2019:

"We of Church Women United-Wisconsin wish to advocate for the humane treatment of children and families and others at the Mexican border. We support all people fleeing from violence and injustice, and we remember that our Lady Liberty welcomes all who come here in peace."

A straw vote of the proposal was acknowledged by those present by a show of hands and referred to the Board for further action. The statement was verbally supported by the Board of Directors present at the meeting at the UCC Conference Center in Deforest, WI on October 10, 2019. Due to a lack of a quorum, we were unable to have an official vote. We asked each unit president to read it at the World Community Day Celebration in November. It was subsequently passed at a later meeting.

The following social justice statement was created by Kris Clausing. It will be voted on at the assembly business meeting on October 22nd.

Church Women United is a racially, culturally, and theologically inclusive Christian women's movement celebrating unity in diversity and working for a world of peace and justice.

Therefore; Church Women United in Wisconsin supports the Black Lives Matter goals to end police brutality and systemic racism in our country. We base our support on the preamble of our Constitution, which lists justice as one of its five goals, and on the Declaration of Independence, which recognizes the rights of all people to life, liberty, and the pursuit of happiness.

We call on our government, our businesses, our educational systems, our law enforcement, and most of all, our individual selves, to step up to meet the challenge to insure fair treatment for all, regardless of race, ethnicity, faith, lifestyle, immigration status or economic means. It is our right and our duty to protest whenever we see any word or deed that interferes with justice and fairness.
